2. No TA/DA will be paid to the candidates to attend the written test/ interview.
3. The duration of the training is for One Year only and extendable by one more year. However, extension for one year may be considered after reviewing the candidate's performance by

management. The tenure of the MITs (Finance) including their extensions period shall not exceed the maximum period of TWO YEARS.

4. Shortlisted Candidate will be called for Written Test/ Interview through email id/ mobile number only (provided in the Application form).
5. Candidates will be shortlisted based on the performance in the written test/ interview which will be conducted at BEL-Ghaziabad.
