QUALIFICATION :

Full Time B.E. / B.Tech /AMIE from AICTE approved College/Institute or a recognised University.

First class in the indicated qualification for General candidates. **Pass class** for PWD candidates.

DISCIPLINE:

The candidates who have acquired BE/B.Tech degree, the following discipline **ONLY** are eligible –
Civil – Civil Engineering

Candidates whose discipline/specialization mentioned in their degree certificate does not tally with the above mentioned discipline/specialization need not apply.

PAY SCALE –

Dy. Engineer (E-II grade) – Rs. 40,000/- 3% - Rs. 1,40,000 + admissible allowances

EXPERIENCE:

Min. 3 years of post qualification industrial experience in the execution/project planning of civil works. The candidate should have relevant experience in construction related activities i.e. execution/supervision of construction work involving building works/renovation works like:

- i. Handling and closing of contract/project.
- ii. Co-ordination with various agencies working at projects.
- iii. Preparation of estimates, tender document and rate analysis.
- iv. Knowledge of CPWD conditions of contract and specification including DSR.
- v. Candidates with proficiency in use of computer software like Auto Cad, MS Projects and MS Office will be preferred.

JOB DESCRIPTION:

Job may involve planning, execution and supervision of construction works, estimation, rate analysis, contract management, etc.

METHOD OF SELECTION:

Selection will be through a Written Test followed by Interview (only for those candidates who will be shortlisted based on their performance in the written test).
