At the convenience of the part-time non-official Directors, Government Nominee and Functional Directors, they shall be nominated for such trainings, seminars, conferences, conventions etc. conducted by Institutions of repute in relevant areas for enhancing their knowledge on Corporate Governance, model code of business ethics and conduct, their responsibilities as directors, and the best ways to discharge them etc. and nomination for such training will be restricted to maximum of two (2) training programs during their tenure.
