### 3.0 UPPER AGE LIMIT & RELAXATION

The upper age limit for candidates belonging to General Category as on 01.06.2024, is 40 years.

The upper age limit will be relaxed by 3 years for OBC (NCL) candidates and 10 years for PwBD candidates (having minimum 40% disability, in addition to the relaxation applicable to OBC (NCL)/SC/ST candidates). The upper age limit admissible considering all relaxations shall be 50 years. Age Relaxation will be extended as per Govt. guidelines in respect of Ex-Serviceman.

#### 4.0 PERIOD OF CONTRACT

Field Operation Engineer will be engaged for a period of 3 years from the date of joining.

- a. The selection process will commence at 10AM. Selection will be through written test followed by interview. Based on the Written Test score, candidates will be shortlisted for interview in the order of merit in the ratio 1:5.
- b. No traveling expenses/allowance will be given for attending the walk in selection.
- c. Candidates have to carefully enter the details in the application and attach the documents as prescribed. Screening and selection will be based on the details provided by the candidates in the application form. Selection will be through a Written Test, followed by an Interview, only for those candidates who qualify in the Written Test. Candidates will be shortlisted for interview in the order of merit in the ratio 1:5 in each category.
