Please note, apprenticeship training is subject to approval of contract by Board of Apprenticeship Training (SR), Chennai.

- You are required to report at Human Resources (HR) Department, **Centre for Learning and Development (CLD)**, Bharat Electronics Limited, Jalahalli, Bengaluru - 560 013 on the mentioned date against your name in the above list at **9.00 AM**. In case if you do not report, we shall presume that you are not interested in this offer and the offer stands cancelled. For whatsoever reasons, reporting on any other date is strictly not permitted.
- You are required to produce the following documents in **ORIGINALS with 1 set of photocopy**:
 - SSLC/10th Marks Card
 - Provisional Degree Certificate/University Convocation Degree Certificate
 - Degree All Semester Marks Cards
 - Aadhar Card
 - Caste Certificate in case of SC/ST/OBC/PWD candidates
 - Police Verification Certificate
 - Medical Fitness Certificate issued by any registered Medical Practitioner/Doctor
 - State Bank of India (any branch) Savings Bank Account Pass Book
 - 1 Passport size & 1 Stamp size Recent colour photographs
- It is mandatory to wear the mentioned uniform at the time of reporting at your own cost.

- During the training period you will be paid only the monthly stipend of **₹12,500/-** (Rupees Twelve Thousand & Five Hundred only). Wherein, **₹8,000/-** will be paid by BEL & **₹4,500/-** will be paid by Govt. through Direct Beneficiary Transfer (DBT). Stipend amount paid will be corresponding to LOP days & short hours on working days.

5. Welfare facilities provided by the company
 - a) Canteen & Transport facilities on chargeable basis
 - b) Free OPD Medical facilities at BEL Hospital
 - c) Group Personal Accident Insurance policy for sum insured is Rupees Five Lakhs
6. Accommodation will NOT be provided by the company.
7. You are required to undergo training diligently as instructed by your superiors from time to time.
8. You should observe all the rules, regulations and safety norms as applicable to the establishment.
9. You are liable to be posted to any Department in the Organization from time to time as deemed fit by BEL Management.
10. Your attitude towards continuation of training would be based on monthly report submitted by the Head of the Department under whom you will be undergoing training. If at any time during the period of training, the Head of the department where you are undergoing training feels that you are not taking sufficient interest in learning, you are liable to be terminated from the training.
11. You will not at any time during your training period be engaged directly or indirectly with any other undertaking / business or employment or activities.
12. You will not at any time during or after the termination of your Training with the Company, disclose to any person whatsoever any information relating to the Company or its customers or any trade secrets of which has come to your knowledge during the training period.
13. Upon successful completion of training, you will cease to be a trainee under the Apprenticeship Act, 1961 and the Company has **NO OBLIGATION** to provide/offer you a job after completion of the training.
14. On completion of period of training, every Optional Trade apprentices may appear for assessment conducted by NATS, to determine his/her proficiency in the trade in which he/she has undergone training.
15. You will be entitled for maximum **12 days Casual leave and 15 days Sick leave** during the training period. In case if you are absent for training for more than the specified leaves, you will not be eligible for Apprenticeship Certificate and may lead to termination from training.
16. If you commit breach of any condition set out herein or neglect your training or for indiscipline or for misconducts, the company may take such action as it may deem appropriate including terminate your training with immediate effect.
17. You are not permitted to bring mobile phone, pen drive and any other electronic gadgets and also you should not carry any official documents.
