TERMS OF ENGAGEMENT & REMUNERATION:

Senior Field Operations Engineer (Sr. FOE)

To be engaged initially for a period of <u>Three</u> years which may be extended up to a period of <u>Two</u> years (<u>Maximum tenure of 5 years</u>) based on project requirement and performance of the Senior Field Operations Engineer. Candidates with 10 years relevant post qualification industrial experience are eligible to apply for the post.

Testing & Commissioning Manager: Candidate must be a Graduate in B.E/B.Tech/B.Sc Engineering (4-year course) in Electronics/Electronics & Communications/Electronics & Telecommunication from a Govt. recognized University/Institute.
