*AGE RELAXATION: The upper age limit will be relaxable for ST candidates by 5 years. For candidates who belong to PwBD category having minimum 40% disability or more will get 10 years relaxation in upper age limit in addition to the relaxation applicable to the categories mentioned above. Candidates from OBC / SC category applying for UR Post will be treated on par with UR criteria.

TERMS OF ENGAGEMENT & REMUNERATION:

Project Engineer-I will be engaged initially for a period of <u>Three</u> years which may be extended up to maximum of <u>ONE</u> year (Maximum tenure of 4 years) based on requirement and individual performance. Candidates will be paid a consolidated remuneration as follows:

In addition to above a consolidated amount of Rs. 12,000/- per year will be paid towards expenses like Medical Insurance & Life Insurance Premiums, Attire Allowance, Stitching Charges, Footwear Allowance etc. This amount shall be paid in two installments. First installment will be processed in the first month's salary after joining and the second installment will be paid after completion of 6 months from the date of joining.

Retention Bonus for Project Engineer: Project Engineers who join as Project Engineer-I and complete overall tenure of 4 years will be entitled for Retention Bonus of Rs. 25,000/- for every completed year. However, the retention bonus will be payable at the end of 4 years i.e. Rs. 1,00,000/-

EXPERIENCE & JOB RESPONSIBILITIES:

- (i) The Candidate should have experience in the field of Electrical Projects: HT/LT Electrical Power Supply System/Diesel Generators, Earthing System, Lighting System, Installation, Testing and Commissioning of infrastructure power projects.

EXPERIENCE & JOB RESPONSIBILITIES:

- (i) The Candidate should have experience in execution of Mechanical projects like Installation & Commissioning of HVAC, Fire Hydrant System etc.
- (ii) Candidate should co-ordinate with the contractor during lying of Water Lines, Fire Hydrant, AHU and Air Conditioning works of the project, Operation and maintenance of Sewage Treatment Plant.
- (iii) The Project Engineer (Mechanical) will be responsible for Measurement of Works and Billing, Maintenance of Plant & Machinery, Site supervision during execution of projects works, coordinate with officials for the water supply and billing.

NOTE:

MODE OF SELECTION

- Selection will be through a written test followed by interview of only those candidates who qualify the written test will be called for interview in the ratio of 1:5 in the order of merit in each category.
- Written Test will consist of objective type questions for 85 marks from Technical domain and General Aptitude.
- All candidates shall secure 35% (GEN/OBC/EWS) and 30% (ST/PwBD) as qualifying marks in written test.





- The assessment weightage will be 85% and 15% for written test and interview respectively.
- Call letters will be sent to the e-mail IDs of eligible candidates for attending the written test. BEL will not be responsible for bouncing of any e-mail sent to the candidate.
- Date, time and center details of the written test will be intimated by e-mail in due course.
- Intimation about the Personal Interview will be given to shortlisted candidates in the Interview Call Letter via e-mail only.
