

Further to the Written Test & Interview, we are pleased to inform you that you are selected as '**Project Engineer-I**' provisionally for HYDERABAD Unit, on following Terms and Conditions:

**TERMS AND CONDITIONS:**

1. You will be engaged for a period of **THREE YEARS** with effect from the date of your joining. Your engagement is subject to the following:
  - a) Satisfactory verification of your credentials/testimonials etc.
  - b) You shall produce a recent medical fitness certificate from a medical officer not below the rank of Civil Surgeon/ Asst. Surgeon.
2. The Provisional Offer of Engagement will not confer any right on you to claim absorption, regularization on any ground in the Company.
3. Your place of posting will be **Hyderabad / Customer locations/ Unit or Offices of BEL, which are located outside of Hyderabad, based on the requirements of the Company.**
4. You will be paid a **consolidated remuneration of Rs. 40,000/- (Rupees Forty Thousand only) per month** during the initial ONE year as Project Engineer - I which will be enhanced to **Rs. 45,000/- (Rupees Forty Five Thousand Only) per month** during the second year as Project Engineer – II and the same will be again enhanced to **Rs. 50,000/- (Rupees Fifty Thousand Only) per month** during the third year as Project Engineer – III. Income tax / Professional tax and other statutory deductions will be made as per rules. Besides this, a consolidated amount of **Rs. 12,000/- (Rupees Twelve Thousand only) per year** will be paid towards expenses like medical & Life insurance premium, attire allowance, stitching charges, footwear allowance etc. the additional amount shall be paid in two installments i.e., First installment will be paid in the first month's salary after joining and the second installment will be paid after completion of 6 months from the date of joining.

5. Based on the requirement of the Company you may be posted to customer locations, which are located at outside of Hyderabad and in such case you are eligible to Area Allowance at the rate of 10% of the consolidated remuneration per month.
6. You will not be entitled to any other benefits applicable to regular employees of the Company such as DA, HRA, PF, Gratuity, Medical, Incentive etc. However, you can avail Company's canteen services on payment basis at the prescribed rates, during your tenure with the organization. You can utilize the Company's transport facility for commuting to factory and back on payment basis.
7. You will be deputed to outstation duties as and when necessity arises. You are also required to work in shifts as decided by the Department Head/Divisional Head.
8. You are eligible for one day casual cum sick paid leave for every completed month of service. Apart from this, you will also be eligible for paid holidays declared for respective Units / Offices (excluding Optional Holiday-OH) based on the location of posting.
9. Your performance will be reviewed periodically with reference to the tasks assigned to you to ensure completion of the assigned Job / Project on time.
10. You shall not communicate, directly or indirectly, any official document or any part thereof, or part with any information, which comes into your possession or knowledge, in connection with your official duties, to any other persons to whom you are not authorized to communicate such document, article, paper, etc., without obtaining prior and specific permission of the superiors. In other words, you shall maintain utmost secrecy of the work related aspects of the assigned Job / Project, any classified / secret / critical information relating to the assigned Job / Project in the interest of the organization.

Further, you shall at all times during the tenure of this engagement:

- (a) Maintain absolute integrity;
  - (b) Maintain devotion to duty; and
  - (c) Do nothing which is against the interest of the Job / Project / Company.
11. You are required to be regular in attendance. In the event of irregular attendance or unauthorized absence, the tenure shall be terminated immediately without notice or compensation in lieu of notice.
  12. This engagement is provisional and is subject to the Caste / Tribe / EWS certificate being verified through proper channel and if the verification reveals that your claim to belong to Scheduled Caste / Scheduled Tribe / Economically Weaker Section as the case may be, is false, then your tenure of engagement with the organization will be terminated without assigning any further reasons and also without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.

13. The Engagement would come to an end on completion of the tenure or on completion of the project whichever is earlier. During the period as Project Engineer – I, II & III as the case may be, either Party may terminate the Engagement with 1 month prior notice in writing or by payment of consolidated remuneration in lieu of notice thereof.
