INSTRUCTIONS FOR WRITTEN TEST CUM INTERVIEW

1. All candidates are required to come prepared with the following documents **in original** along with one set of self-attested photocopies of the same for document verification, failing which the candidature will summarily be rejected.

- SSLC/Xth Marksheet as proof of date of birth.
- PUC / 12th Class Marks card
- Final degree/ Provisional Degree certificate of relevant qualification.
- Proof of norms for CGPA/DGPA/OGPA or letter grade/document for percentage/class issued by University/Institution/College.
- Caste/Tribe/Community/Disability/Economic status Certificate in case of candidates belonging to SC/ST/OBC/PwBD/EWS respectively. Candidates claiming reservation under any of the above categories are required to submit the certificate in the prescribed format. The formats of various certificates are provided as link to the advertisement. Candidates belonging to OBC category should produce the Certificate applicable for the FY 2023-24 and for EWS certificate valid Income & Asset certificate must be produced.
- Post qualification work experience certificate/s from previous/ current employer.
- Candidate employed on permanent/fixed term basis in Govt./Quasi Govt. and Public Sectors Undertaking should compulsorily submit the 'No Objection Certificate' along with the application.
- Candidates employed on temporary basis in Govt./Quasi Govt. and Public Sector Undertaking should compulsorily submit Offer of Appointment and latest payslip.
- 2. If you fail to produce any of above certificates, you will not be allowed to attend the Written Test / interview (for those candidates will shortlisted for interview after written test on same day). You may also note that you have the option of answering the question in "HINDI" during the interview.
- 3. NOC: In case you are already working in Central/State Government, Public Sector Undertaking or Autonomous Body/Institution and your application was not forwarded through proper channel, you must bring a 'NO OBJECTION CERTIFICATE 'from your present employer otherwise you will not be allowed to appear for the interview.
- 4. BEL reserves the right to debar you at any stage of the selection process, if your candidature is considered not suitable for any reason. Canvassing in any form will result in disqualification.
- 5. Please note that during subsequent verification of certificates/testimonials (including mark sheets) in case the verification reveals contrary to your claim, your candidature will be summarily rejected at any stage of the selection process without any further notice to you.
- 6. This card provisionally allows you to appear in the written examination on the basis of particulars provided by you in the application. Issuance of this admits card does not necessarily mean acceptance of eligibility. Please further ensure that you fulfill all the eligibility criteria (like age, qualification, experience, category certificate, etc.) as stipulated in our advertisement. If you fail to meet any of the eligibility criteria as stated in the advertisement for the post, your candidature will be cancelled forthwith and you will not be allowed to appear further in the process of selection. The decision of the management in this regard would be final.
- 7. This Admit card does not constitute an offer of employment.
- 8. This call letter is issued based on the information submitted by the candidates in the application form for the above recruitment. If at any point of time, any discrepancies in any of the eligibility

criteria are found the candidature of the candidate will be cancelled.

- 9. Candidates are advised to visit the Exam Centre at least one day in advance so that they can reach the Exam Centre on the date of the exam in time.
- 10. On exam day candidates must report at the exam centre at the scheduled reporting time, but in any case, not after the Gate Closing Time, after which, no candidate will be permitted entry under any circumstances.
- 11. Carry printout of this admit card to the exam centre for being allowed entry into the exam centre. (Digital copy is not acceptable). Also carry any valid original Photo ID proof, such as, Voter ID Card, PAN Card, Driving Licence, Passport, Aadhar Card, Photo ID issued by any government organization, for verification at the exam centre. You will not be permitted entry without the same.
- 12. If any candidate is found in an inebriated state, he/she will not be allowed entry to the exam centre.
- 13. Candidates should follow the instructions of the Invigilator/Centre Superintendent of the exam centre concerned. Non-observance thereof shall result in disqualification / rejection of the candidature of defaulting candidate(s).
- 14. Please note that the items listed below are strictly NOT allowed inside the examination centre campus:
 - Mobile phone, Bluetooth device, pagers/iPad/iPod/Tablets/Tablets ear buds or any electronic gadgets/ equipment, digital/smart watch, bag, handbag, papers, notes, books, calculator, correction marker/white fluid, etc. are strictly NOT allowed inside the Exam Centre.
 - There shall be no arrangement at the Exam Centre for keeping the aforesaid items. If any item is brought by the candidate and the same is lost, BEL will not be responsible for such loss. Possessing any electronic device such as mobile phone or any electronic equipment by the candidate inside the examination centre campus before completion of examination will be considered as attempting to take or send the Question Booklet in fill or in part outside the examination room. Appropriate civil and/or criminal proceedings will be initiated against any candidate taking or attempting to take or send the Question Booklet in full or in part outside the examination room besides cancellation of his/her candidature.
- 16. You must bring transparent-type Ball Point Pens (black/blue) only for writing the test.
- 17. If any candidate is found to be indulging, at any stage of the Exam, in any malpractice/ irregularity, using or in possession of unauthorized material or indulging in copying or adopting unfair means, etc., his/her candidature shall summarily be disqualified/rejected/cancelled for this recruitment process. He/she will also be debarred for other recruitment processes conducted by Bharat Electronics Limited, apart from legal action as per law, without any notice in this regard and such decision of Bharat Electronics Limited shall be final.
- 18. Candidates belonging to "Person with Disability" category and have mentioned in the application form that their disability is such that it causes limitations in writing, would be granted additional time of 20 minutes (@20 minutes per hour of test).
- 19. Any case of impersonation shall be treated as crime and action shall be taken as per law.
- 20. Any attempt to influence will lead to disqualification/rejection of candidature.
- 21. Furnishing of false information or concealment / suppression of factual information will render the candidate unfit for employment.
- 22. Candidates are NOT required to provide/share their personal particulars like Mobile No, Email Id, Address, etc. to anybody inside or outside the exam centre.
