5.0 UPPER AGE LIMIT & RELAXATION

Field Operation Engineer: The age limit should not be more than 40 years for General/ EWS candidates. The upper age limit will be relaxable for OBC (NCL) candidates by 3 years and SC/ST candidates by 05 years. For candidates belonging to PwBD category having 40% disability or more will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

Project Engineer: The age limit should not be more than 32 years for General & EWS candidates. The upper age limit will be relaxable for OBC (NCL) candidates by 03 years and SC/ST candidates by 05 years. For candidates belonging to PwBD category having 40% disability or more will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

SSLC/ SSC/ ISC mark card and any other valid document will be considered as proof of date of birth.

Please Note:

 2. The selections for the post of Project Engineers will be conducted at Bhopal and Ahmedabad. Candidates who wish to appear for the selection process at both the locations are required to preregister for both the locations separately.
- b. The selection process will commence at 08:00 AM. No candidate will be allowed to enter the venue after 08:30 AM. Selection will be through written test followed by interview. Based on the Written Test score, candidates will be shortlisted for interview in the order of merit in the ratio 1:5 in each category.
