**ELIGIBILITY CRITERIA:**

1. The candidate should have passed 4-year BE/B.Tech in abovementioned branches recognized by AICTE or GOI on or after 09.12.2022.
2. The candidate should have passed 3-year Diploma in abovementioned branches recognized by SBTET or GOI on or after 09.12.2022.
3. Age limit: Maximum Age limit 25 years as on **09.12.2025** (Upper age limit is relaxation by 5 years for SC/ST, 3 years for OBC candidates and 10 years for PWD candidates).
4. Minimum Percentage in Graduation for General & OBC candidates should be 60% & above. For SC/ST candidates minimum Percentage in Graduation should be 50% & above.
5. Candidates who have undergone or undergoing Apprenticeship Training under NATS in any **other establishment/organization are strictly not eligible.**

6. Candidates who have acquired or pursuing higher qualifications are not eligible.
7. Candidates who do not possess Degree/Provisional Degree certificate are not eligible.
8. Candidates should register in NATS 2.0 portal Direct Link: <https://nats.education.gov.in/> and fill your Personal, Academic and Bank details, after completing 100% Profile take print out of Registration form.

#### **FACILITIES PROVIDED TO APPRENTICES:**

1. **GRADUATE APPRENTICESHIP (BE/BTECH):** Monthly stipend is Rs.17,500/- (Rupees Seventeen Thousand & Five Hundred only). Out of Rs.17,500/- stipend amount:Rs.13,000/- will be paid by BEL&Rs.4,500/- will be paid by Govt. through Direct Benefit Transfer (DBT).
2. **TECHNICIAN APPRENTICESHIP (BE/BTECH):** Monthly stipend is Rs.12,500/- (Rupees Twelve Thousand & Five Hundred). Out of Rs.12,500/- stipend amount:Rs.8,500/- will be paid by BELRs.4,000/- will be paid by Govt. through Direct Benefit Transfer (DBT).
3. Free transportation and subsidised canteen facilities will be available.

#### **SELECTION PROCESS:**

1. Selection is on the basis of merit based on marks secured in the Written Test and Interview.
2. Shortlisted candidates will be informed through E-Mail only.

#### **OTHER INFORMATION:**

1. Candidates who fulfil the above conditions only need to attend Walk-in-Selection.
2. The duration of the Apprenticeship Training is ONE year.
3. No TA/DA will be provided to the candidates for attending Walk-in-Selection.
4. During the period of apprenticeship, candidates will be governed by the 'Apprentices Act, 1961 as well as the policies/rules of the organization.
